2. Attach a check or money order in the amount of \$25.00 made payable to the "Secretary of State Jim Miles."
3. **RETURN APPLICATION AND CHECK TO YOUR COUNTY DELEGATION OFFICE LISTED BELOW.**
4. **COUNTIES WITHOUT A LISTED DELEGATION OFFICE:** mail your application to the House of Representatives.
5. Your Commission will be mailed within one week upon receipt by this office of a properly executed application. You have fifteen (15) days to hand carry your Commission to the **County Clerk of Court's Office** in the County of your residence located at your County Court House to register your Notary Commission.
